On May 18, 2023, MPARK shares with TL 105,000 nominal value were repurchased within a price range of TL 61.45 – TL 62.90 (weighted average TL 62.11) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of May 18, 2023, total nominal value of repurchased shares have become TL 11,962,000 which represents 5.7499% of the share capital, following the transactions.
