On June 23, 2023, MPARK shares with TL 25,000 nominal value were repurchased within a price range of TL 74.15 – TL 75.75 (weighted average TL 75.14) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of June 23, 2023, total nominal value of repurchased shares have become TL 12,975,000 which represents 6.2369% of the share capital, following the transactions.
