On September 4, 2023, MPARK shares with TL 20,000 nominal value were repurchased within a price range of TL 127.40 – TL 129.80 (weighted average TL 128.62) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of September 4, 2023, total nominal value of repurchased shares have become TL 14,050,000 which represents 6.7536% of the share capital, following the transactions.
