On September 18, 2023, MPARK shares with TL 39,000 nominal value were repurchased within a price range of TL 125.30 – TL 134.40 (weighted average TL 128.89) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of September 18, 2023, total nominal value of repurchased shares have become TL 14,259,000 which represents 6.8541% of the share capital, following the transactions.
