On October 2, 2023, MPARK shares with TL 33,000 nominal value were repurchased within a price range of TL 141.70 – TL 145.90 (weighted average TL 143.77) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of October 2, 2023, total nominal value of repurchased shares have become TL 14,500,000 which represents 6.9699% of the share capital, following the transactions.
