On October 24, 2023, MPARK shares with TL 33,000 nominal value were repurchased within a price range of TL 146.10 – TL 149.70 (weighted average TL 148.32) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of October 24, 2023, total nominal value of repurchased shares have become TL 15,024,000 which represents 7.2218% of the share capital, following the transactions.
