On November 13, 2023, MPARK shares with TL 30,000 nominal value were repurchased within a price range of TL 161.60 – TL 168.50 (weighted average TL 164.51) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of November 13, 2023, total nominal value of repurchased shares have become TL 15,600,000 which represents 7.4987% of the share capital, following the transactions.
