On November 24, 2023, MPARK shares with TL 28,000 nominal value were repurchased within a price range of TL 158.70 – TL 160.50 (weighted average TL 160.10) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of November 24, 2023, total nominal value of repurchased shares have become TL 15,807,500 which represents 7.5984% of the share capital, following the transactions.
