On November 28, 2023, MPARK shares with TL 25,500 nominal value were repurchased within a price range of TL 158.70 – TL 163.50 (weighted average TL 162.62) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of November 28, 2023, total nominal value of repurchased shares have become TL 15,873,000 which represents 7.6299% of the share capital, following the transactions.
