On November 30, 2023, MPARK shares with TL 166,000 nominal value were repurchased within a price range of TL 148.40 – TL 153.70 (weighted average TL 149.67) per share on Istanbul Stock Exchange by MLP Sağlık Hizmetleri A.Ş.,

As of November 30, 2023, total nominal value of repurchased shares have become TL 16,134,000 which represents 7.7553% of the share capital, following the transactions.
